VISA AND FINANCE INFORMATION

Thousands of students from all over the world annually come to Ireland to study. Dublin Business School's student body consists of approximately

30% international students hailing from over 70 different countries.

The Irish Student Visa regulations permit students to study, work and live in Ireland for up to 7 years which includes the right to work in casual employment part-time (20 hours per week) when studying and full-time (40 hours per week) when academic break during their studies.

Additionally there is also a [Third Level Graduate Scheme](#).

Graduates with an award at Level 8 on the National Framework of Qualifications will be granted a period of residence in the State, the lesser of either, twelve months or such period as would bring their overall time resident in the State (i.e. time spent on Stamp 2 as a student and on Stamp 1G under this programme) to seven years in total.

Graduates with an award at Level 9 or above on the National Framework of Qualifications qualify for the Programme will be granted permission for twenty-four months to a maximum of eight years' student permission overall (i.e. time spent on Stamp 2 as a student and on Stamp 1G under this programme cannot exceed an aggregate time of eight years in total).

FIRST REGISTRATION WITH INIS

If you are allowed into Ireland, an immigration officer at border control will stamp your passport and then add a date to the stamp.

You must visit a registration office in person before this date to:

- Apply for permission to stay here, ie to study
- Register your details with immigration
- If you don't get permission/register in time, you may have to leave the country.

You must bring:

- Your passport
- An original Letter of Acceptance from a college/university confirming you have been accepted & enrolled (see note 1 below)
- Proof that you have paid any college/university fees (see note 2 below)
- Proof of scholarship funding (if appropriate) (see note 3 below)
- Proof that you have private medical insurance (see note 4 below)

If you did not need a visa to come to Ireland, you must also prove that you can support yourself financially after you arrive here. You do this by showing you have direct access to:

- €3,000, if you are staying for more than 6 months (see note 4 below)
- €500 per month or €3,000 (in total) if you are staying 6 months or less
- If any of these are missing, you cannot be given permission to stay and won't be registered.

Cost & payment options

You must pay a fee of €300 per person to register. You can pay by:

- Bank giro: A giro is a pre-printed form and can be collected from any registration office.
- Credit card or debit card: These can be used at Burgh Quay Registration Office and some others.

Hostels

MEDICAL INSURANCE

All students from outside the EU/EEA must obtain medical insurance as a requirement of their Irish study visa. Immigration Service Delivery requires that this insurance must include hospital cover and a minimum of €25,000 for Accident and €25,000 for Disease. Students must buy their own medical insurance as it is not provided by DBS.

Students may purchase medical insurance in their home country prior to travel for their first year only in Ireland provided it meets these requirements.

Courses with a Duration of 12 months or less (Postgraduate/ MBA/ MSc)

If you are coming to Ireland to study on an academic course of one year or less, basic medical expenses insurance policies are available for approximately €160. These insurance policies will satisfy the visa/immigration requirement for private health insurance and can be

obtained before students arrive in Ireland. The following policies are only available for students for courses of 12 months or less:

Courses with a Duration of more than 12 months (Undergraduate)

Students studying a course of more than 12 months must buy private medical insurance. [Studyandprotect.com](https://studyandprotect.com) provide a policy which meets this requirement.

Comprehensive plans are also available from one of the three main private health insurance companies in Ireland: [VHI](#), [Irish Life](#) or [Laya Healthcare](#).

There are a large range to choose from and the HIA (Health Insurance Authority) have a [comparison tool](#) to help you decide on the best policy to suit your needs, budget and the requirements for your student visa.

Graduates

Medical insurance is a requirement for graduates on the Third Level Graduate Scheme (Stamp 1G or 1A) which must include hospital cover and a minimum of €25,000 for Accident and €25,000 for Disease.

Graduates can buy Graduate Medcover from [Study& Protect](#). This policy is designed specifically for International graduates and currently meets visa requirements.

If graduates are working and their employer provides medical insurance that meets the visa requirements they can submit this with their visa application.

Graduates can also buy private health insurance from any provider in Ireland. There are a large range of policies that you can choose from and the HIA (Health Insurance Authority) have a [comparison tool](#) to help you decide on the best policy to suit your needs, budget and the requirements for your graduate visa.
